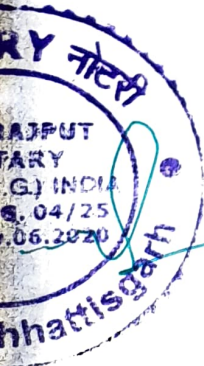
APPENDIX-IV
